We are excited for the 3<sup>rd</sup> Annual Charity Challenge Invite. The Charity Challenge Series has donated over \$100,000 to your chosen charities!

**We will still split your team earnings\*!**

**50% to the charity, 50% to your gym**

*(\*teams must earn over \$200 for 50/50 split. Less than \$200 all earnings will go to your charity)*

Here is how your team will earn money towards your charity:

- \$20 from each athlete on the team
- \$2 from every door entry fee from your team's spectators
- Team awards
  - 1<sup>st</sup> Place - \$40
  - 2<sup>nd</sup> Place - \$20
  - 3<sup>rd</sup> Place - \$10
- \$2 for each Individual All-Around 1<sup>st</sup> Place
- \$1 for each Event 1<sup>st</sup> Place
- \$50 Highest Team Score for the weekend
- \$25 Highest All-Around for the weekend - gymnast will also earn a leotard gift certificate
- \$10 Highest Event Score
- \$100 Team Spirit Award - The team who displays the most support for their charity
- The team that raises the most money for their charity (during the meet...outside fundraising will not count) will earn a \$500 Gift Certificate for equipment from Lightning City Gymnastics as well as \$100 for an athlete party at your gym.
- The second and third teams to raise the most money will receive \$50 for an athlete party as well as a case of chalk.

**The team which earns the most money for their charity will earn the Charity Challenge Cup!**

A trophy will be awarded to the team earning the most money from either the Charity Challenge Invite in October, this meet or a combination of both. Last year winner was Lakewood Ranch Gymnastics!

The team will earn a trophy for their gym as well as have their team's name added to the official Charity Challenge Cup trophy along with Tampa Gymnastics, LaFleur's Largo and Lakewood Ranch! The winner of the cup will also receive 3 free team entries to the 2022 Charity Challenge Invite in the Fall and the 2023 Charity Challenge Cup in the Spring. Additionally, they will receive 5 individual entries for both meets. The 2<sup>nd</sup> and 3<sup>rd</sup> place overall winners will win a case of chalk.

Rules for designating your team charity:

- Must be a non-profit organization
- Gym booster clubs cannot be considered as your charity
- Special situations must be approved by Lightning City Gymnastics
