Clubs that need the final 2 weekends before the state meet to qualify an athlete will have the choice to enter the athlete by deadline date with no refund if they do not qualify – or wait and if the athlete qualifies then enter the athlete late paying the entry fee plus the \$50 late fee. NO entries will be accepted after the Monday at Noon the week of the State meet.

Refunds for injuries will be given up until 10 days prior to the first day of the meet with medical verification. (Tuesday, March 17, 2026)
